Sub: Application for letter of permission for functioning of Nootan Homoeopathic Medical College and Hospital, Gat No. 412, Landgewadi, Tal. Kavathemahankal, Dist. Sangali, Maharashtra- 416405 for Admission in BHMS Undergraduate Course with Intake Capacity of 60 seats for academic year 2025-26 – reg.

Sir/Madam,

Nootan Homoeopathic Medical College and Hospital has submitted an application for permission for sanction of 60 seats in BHMS course for academic year 2025-26. The College has submitted the Part I information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board (MARBH) has conducted Inspection on 18.06.2025 and 19.06.2025, followed by virtual hearing on 02.07.2025. MARBH has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards 2024 as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls: -

1. Deficiency of Teaching Faculty (10 deficiencies)

- Department of Anatomy: One Professor, One Associate Professor are not available.
- Department of Physiology and Biochemistry: One Associate Professor is not available
- Department of Organon of Medicine and Homoeopathic Philosophy and fundamentals of Psychology: One Professor is not available.
- Department of Pathology: One Professor is not available.
- Department of Practice of Medicines with essentials of pharmacology: One Professor, One Associate Professor are not available.
- Department of Gynecology & Obstetrics: One Associate Professor is not available.
- Department of Community Medicine and Research Methodology: One Professor is not available.
- Department of Repertory and Case Taking: One Professor is not available.

As evident from the above statement, a total number of 10 UG teachers are deficient against the requirement of 40 + 1 for 60 seats UG college (As specified in MES, 2024). Pursuant to F.No.:3-2/MARBH/NCH/2025-26/162-169 dated 16/04/2025 issued by MARBH, a college can avail 15% relaxation against the required number of teachers for Academic Year 2025-26 only. After allowing relaxation of 15%, college has 04 deficiency of teacher. However, such relaxed number of teachers may be appointed at the earliest for smooth conduct of course.

2. Miscellaneous:

- NABL accreditation for clinical laboratory not done.

3. Considering the above observations during inspection and hearing, MARBH has decided to issue **Conditional permission to Nootan Homoeopathic Medical College and Hospital, Gat No. 412, Landgewadi, Tal. Kavathemahankal, Dist. Sangali, Maharashtra- 416405 for continuing UG (BHMS) course with intake capacity of 60 seats for academic year 2025-26, on the basis of following conditions:-**


- NABL accreditation for clinical laboratory to be done.
- One Professor in Department of Anatomy to be appointed.
- One Professor in Department of Organon of Medicine to be appointed.
- One Professor in Department of Pathology to be appointed.
- One Professor in Department of Repertory to be appointed.

The institute will rectify all the above deficiencies within a month and compliance shall be submitted to MARBH, failing which permission may be withdrawn.

4. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under All India Quota shall be conducted by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT designated by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India Quota or the student admitted thereunder.
5. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.
